OCTOBER 19TH DEADLINE FOR EQIP APPLICATIONS

The deadline for next year's Environmental Quality Incentives Program (EQIP) allocation is quickly approaching. If you are interested in signing up, applications must be completed no later than October 19th to be eligible for the first round of funding.

In Iowa, EQIP funds will be paired with the Watershed Improvement Review Board (WIRB) grant to provide up to 75% cost-share for terraces, water and sediment control basins, and grade stabilization structures (ponds).

Minnesota landowners are encouraged to contact the NRCS office in Caledonia at 507-724-5261 to inquire about current EQIP rates for specific conservation practices.

POSSIBLE NEW WIRB FUNDS FOR IOWA

The Allamakee SWCD (SWCD) has learned of a possible new funding allocation through the Iowa Watershed Improvement Review Board (WIRB).

In August 2012, the SWCD was awarded a two-year grant through the WIRB for terraces, water and sediment control basins, and grade stabilization structures (ponds). Funding through this grant will end in early 2015.

If a new request for applications is announced, the SWCD is considering submitting an application for the following practices: **agricultural waste structures, streambank stabilization, and pasture management**. However, an application will only be submitted if landowners are identified for practices beforehand.

If there is no interest, an application will not be submitted. If you are interested in any of these practices, please contact us immediately and we will meet with you on your farm to conduct an assessment.

According to their website, the WIRB was established in 2005 by the Iowa Legislature to provide grants to watershed and water quality projects. The WIRB is comprised of representatives from agriculture, drinking water and wastewater utilities, environmental organizations, agribusiness, the conservation community along with two state senators and two state representatives.

The WIRB is administered by the Iowa Department of Agriculture and Land Stewardship—Division of Soil Conservation.

BMPs UPDATE

Several Best Management Practices (BMPs) are scheduled to be constructed this fall in the watershed.

In Iowa, 3150 feet of terraces, one water and sediment control basin, and two ponds are scheduled construction this fall. Two additional ponds are scheduled to be probed next month, with a tentative construction date of next spring. Surveys, designs, and cost estimates have been completed for four more landowners. Throughout this summer, several on-site visits have been done to assess potential BMPs.

In Minnesota, 300 acres of cover crops will be planted this year. For a complete update on BMPs in Minnesota, please contact the NRCS office in Caledonia at 507-724-5261.
